Coats is a certified executive coach in the Marshall Goldsmith Stakeholder Centered methodology and works primarily with executive-level leaders and teams, and a member of the Forbes Coaches Council. Coats is also president of C2 Advisors, providing advisory services that leverage her wideranging professional network and expertise in strategy, marketing, entrepreneurship, family enterprise, social innovation and the capital markets. Coats is a key advisor to CEOs and executives of numerous innovative and high-growth companies.

Most recently, Coats was executive-in-residence at the nationally ranked Crummer Graduate School of Business at Rollins College in Winter Park, FL, focused on leadership and innovation, and is currently an adjunct member of the leadership faculty. Coats

Prior positions Coats has held include chief operating officer, chief strategy officer and chief marketing officer within CNL Financial Group, a leading private investment management firm providing global real estate and alternative investments with a cumulative \$28 billion in assets under management, corporate officer for CFG and its subsidiary CNL Investment Company, corporate officer and founding executive of CNL Real Estate Advisors, a CFG subsidiary which reached \$200M in equity raised and \$650M in assets under management in its first year. While at CNL Financial Group, Coats led an exhaustive growth strategy process in partnership with McKinsey and Company.

Following her departure from CNL, Coats served a key advisory role in the start-up and rapid growth of Franklin Square Capital Partners, a leading alternative investment company which pioneered the Business Development Company as a non-traded security in the retail investment space. Coats also led a year-long growth/exit strategy for one of the largest privately held, family-owned beverage distributors in the U.S. that strategically positioned the company for a significant exit with a double-digit multiple.

Additional positions held by Coats include executive vice president of the NBA-franchise Orlando Magic, president of RDV (Rich DeVos) Team Charities and producer/co-host of the nationally syndicated television show PM Magazine. Coats' longest standing role was a 16-year career with the Orlando Magic/RDV Sports where she played a key part in securing the franchise for Orlando, joined the staff as part of the founding management team and quickly rose to one of the highest-ranking women in professional sports. Coats was instrumental in the start-up and growth of RDV Sports and all of its holdings, the Orlando Magic, Orlando Solar Bears of the IHL, Orlando Miracle of the WNBA and RDV Sportsplex. Coats also worked closely with RDV Corporation, the family office of the DeVos family, owners of RDV Sports and Amway Corporation, among numerous other assets.

Upon departing RDV Sports Coats completed her Global MBA at Duke University and was promptly tapped by then newly-elected Orlando Mayor Buddy Dyer to Chair his Downtown Strategic Transition Team. Coats and her blue-ribbon committee developed the Downtown Blueprint Plan that has become the roadmap of Mayor Dyer's vision for Downtown Orlando and the catalyst for its explosive growth. A close advisor of Mayor Dyer, Coats has served on numerous civic initiatives under his tenure. Her visionary leadership for Downtown Orlando continued in her most recent role as Chairman of the Executive Advisory Board for Project DTO (Downtown Orlando), a strategic planning initiative that will take Orlando into the next decade.

Coats is a frequent speaker and lecturer on the topics of innovation and entrepreneurship, leadership, strategy and growth, social innovation and women's business issues.
